<b>REFUND POLICY:</b> It is to the financial advantage of all students withdrawing, or dropping, classes to do so as early in the semester as possible. Refunds for <b>tuition and required fees*</b> will be made as follows for students who withdraw or drop to a lower block of credit hours:

<i>Student Health Insurance:</i>	No refunds are available after the first ten (10) class days starting with the first official day of classes for the University.
