



Summer 2019 - Withdrawl Refund Schedule Main Campus/ Distance Education

Last Day for Refunds

First Summer Session (Term 201940): Last Day for Refunds- May 17
 Eleven-Week Summer Session (Term 201950): Last Day for Refunds- June 10
 Second Summer Session (Term 201960): Last Day for Refunds- June 26

REFUND POLICY: It is to the financial advantage of all students withdrawing, or dropping, classes to do so as early in the semester as possible. Refunds for **tuition and required fees*** will be made as follows for students who withdraw or drop to a lower amount of credit hours:

*Beginning May 18, 2019 (the 6th consecutive day of Class for Summer Session 1) and June 27, 2019 (the 6th consecutive day of class for Summer Session 2) refunds will not be considered . Special Course Fees: There will be no refunds available on special course fees including but not limited to private music fees, remedial math, or nursing fees after the first five (5) class days starting with the first official day of classes for each Summer Session.

Any refunds that a student becomes entitled to shall first be applied to outstanding financial institutional charges owed to the University.
