Friday, March 22 nd	Early Registration
Monday, March 25 th	Registration for Summer 2024 begins
Monday, April 8 th	First eBill notification for all campuses

Wednesday, May 1 st	Postmark date for mailing payments for Summer Session 1 and 11-Week Summer Session
Wednesday, May 8 th	All billing statements are due for both Summer Session 1 and 11-Week Summer Session. All outstanding balances on your billing statement must be paid in full.
