



Summer 2024 - Withdrawal Refund Schedule Main Campus/Distance Education

Last Day for Refunds

First Summer Session (Term 202440): Last Day for Refunds- May 17
 Eleven-Week Summer Session (Term 202450): Last Day for Refunds- June 10
 Second Summer Session (Term 202460): Last Day for Refunds- June 26

REFUND POLICY: It is to the financial advantage of all students withdrawing, or dropping, classes to do so as early in the semester as possible. Refunds for **tuition and required fees*** will be made as follows for students who withdraw or drop to a lower amount of credit hours:

*Beginning May 18, 2024, and June 27, 2024, refunds will not be considered. If a student wishes to appeal, the process must be initiated in writing to the Tuition Refund Appeals Committee: TUITIONAPPEALS@ECU.EDU

**NO refunds will be considered after the designated limited refund period(s).
 To officially withdraw, a student must give written notice to the Office of the Registrar.
 You may be responsible for payment of all charges if you do not officially withdraw.**

Other Refunds*

Special Course Fees:

There will be no refunds available on special course fees including but not limited to private music fees, remedial math, or nursing fees after the first five (5) class days starting with the first official day of classes for each Summer Session.

Any refunds that a student becomes entitled to shall first be applied to outstanding financial institutional charges owed to the University.
